



# **2024 YOUTH EXPERIENCES SURVEY REPORT**


All the participants of the 2024 YES survey were between the ages of 18 and 25 years of age.



The participants identified as either male, female, transgender, genderqueer or other.

## SHELTER AND HOUSING

Respondents described a variety of current housing and shelter accommodations



Almost all (n = 220) of the respondents experienced homelessness in their life. Their first experience occured between the ages of 6 and 25.

Average age of first homeless experience = 16.9



Over half of the respondents (n = 158) reported being kicked out of their home (N = 227).

## SEXUAL ORIENTATION

The sexual orientations identified were heterosexual, bisexual, asexual, pansexual, lesbian, gay, or other.

Almost half of the participants (46.7%) identified as LGBTQIA. The rest (53.3%) identified as heterosexual.

## **EDUCATION**

Almost half of the respondents (42.3%) reported that they had dropped out of school at one point in time.


The reasons for dropping out included homelessness (57.3%), moving around a lot (51%) academic difficulty (21.1%).





## **CHALLENGES** N = 227


Drug use use was reported by nearly half of the respondents (46.7%) with the first experience ranging from 6 years to 21 years old.







Being rejected by family and kicked out of the house was reported by over two-thirds of the respondents (69.6%). The age of being kicked out ranged from 9 years to 22 years old, with the average of 16.5 years old. The reasons for being kicked out:

## **WORK AND FAMILY**

Respondents described a variety of activities to earn money to live.

## **ADVERSE CHILDHOOD EXPERIENCES**

The majority of participants (81.1%) reported experiencing at least one ACE in their lifetime.

Over half of participants (63%) reported experiencing 4 or more adverse childhood experiences in their lifetime.

## **DOMESTIC VIOLENCE EXPERIENCES**

Almost half of the participants (45.4%) observed their parent hit or beat another parent.

Being hit, kicked, or physically assaulted by a romantic partner was reported by a third of respondents (35.7%).




# DEMOGRAPHICS: SEX TRAFFICKED N= 70

Sex trafficking was reported by 70 respondents of the total YES survey (N = 227). The average age of their first sex trafficking experience was 15.6 years old. The age ranged from 4 years to 22 years old.


Sex Trafficked participants identified their relationship with their traffickers illustrated below.

The following is an illustration of the racial indentities of the sex trafficked participants (n = 70) with 4 missing.




# **SHELTER AND HOUSING**

Respondents described a variety of current housing and shelter accommodations (n = 70).

More than half (55.7%) of the sex trafficked participants first experienced homelessness as a child. The average age of homelessness was 16.4 years old. Majority of the respondents (91.4%) reported being previously kicked out of their home. The average age of rejection was 16. Below are the reasons for rejection.

## ADVERSE CHILDHOOD EXPERIENCES

Sex trafficked participants experienced an average of 6 ACEs.

Over half of participants (n = 57) reported experiencing 4 or more adverse childhood experiences in their lifetime.

## DOMESTIC VIOLENCE EXPERIENCES

Almost half of the participants (62.9%) observed their parent hit or beat another parent.

Being hit, kicked, or physically assaulted by a romantic partner was reported by over half of respondents (68.6%).




# DEMOGRAPHICS: LABOR TRAFFICKED N= 33

Labor trafficking was reported by 33 respondents of the total YES survey (N = 227). The average age of their first labor trafficking experience was 15.7 years old. The age ranged from 8 years to 22 years old.


Labor Trafficked participants identified their relationship with their traffickers illustrated below.

The following is an illustration of the racial indentities of the labor trafficked participants (n = 33) with 2 missing.




# **SHELTER AND HOUSING**

Respondents described a variety of current housing and shelter accommodations (n = 33).

More than half (51.5%) of the labor trafficked participants first experienced homelessness as a child. The average age of homelessness was 17.3 years old. Majority of the respondents (93.9%) reported being previously kicked out of their home. The average age of rejection was 16. Below are the reasons:



## ADVERSE CHILDHOOD EXPERIENCES

Labor trafficked participants experienced an average of 7 ACEs. The majority reported experiencing more than one (93.1%).

Over half of participants (78.8%) reported experiencing 4 or more adverse childhood experiences in their lifetime.

## DOMESTIC VIOLENCE EXPERIENCES

Over half of the participants (54.5%) observed their parent hit or beat another parent.

Being hit, kicked, or physically assaulted by a romantic partner was reported by over half of respondents (63.6%).

## ACES

155 out of 227 (68.3%) participants answered yes to the question:

"Did a parent or other adult in the household often or very often swear at you, insult you, put you down, or humiliate you or act in a way that made you afraid that you might be physically hurt?"

142 of the 227 (62.6%) participants answered yes to the question:

"Did you often or very often feel that no one in your family loved you or thought you were important or special or your family didn't look out for each other, feel close to each other, or support each other? at least one ACE in their lifetime."

141 out of 227 (62.1%) participants answered yes to the question: "Were your parents ever separated or divorced?"

125 out of 227 (55.1%) participants answered yes to the question: "Did a parent in the household have a drug or alcohol problem?"

105 out of 227 (46.3%)participants answered yes to the question: "Was a household member depressed or mentally ill, or did a household member attempt suicide?"

69 out of 227 (30.4%) answered yes to the question: "Did a household member go to prison?"

57 out of 227 (25.1%) answered yes to the question:

"Did an adult or person at least 5 years older than you ever touch or fondle you or have you touch their body in a sexual way or attempt or actually have oral, anal, or vaginal intercourse with you?"

# **IMPLICATIONS**

Ongoing needs for homeless young adults in the state of Arizona:

- Youth focused safe channels for reporting exploitation & technology based outreach tools
- More access to low-barrier transitional housing
- Targeted services for high-risk groups, such as LGBTQIA+ youth
- Accessible trauma informed mental health care

### With regard to sex trafficking and labor exploitation:

- Social serving agencies must be equipped to screen for the presence of these forms of exploitation and their staff must be trauma-informed and trained in culturally responsive practices
- Maintain drop-in centers, mobile resource units, and consistent street outreach as essential services
- Social services, schools, healthcare systems, law enforcement, and housing providers must work together to build collaborations and support victims of exploitation
- Additional funding opportunities from local and state government should be made available to specifically target service provision for this population.

### Homelessness as a Child

- Recognize that many unsheltered young adults experienced homelessness and signifcant trauma prior to adulthood
- Prioritize early intervention for school-aged children facing poverty, abuse, or academic difficulties as part of homelessness and exploitation prevention efforts.
- Implement prevention programs that include school-based intervention, housing instability screenings, and family stabilization services.
- Support continued research to understand childhood pathways into homelessness and exploitation and to identify key intervention points that can shift long-term outcomes.
